# **Terms & Conditions**

# Allegion General Terms and Conditions of Sale and Service

#### 1 APPLICABILITY AND VARIATION

- 1.1 These Allegion general terms and conditions (the 'Terms') apply to all proposals, quotations and contracts issued or entered into by Allegion.
- 1.3 No variation to these Terms shall be applicable unless explicitly agreed in writing by an authorized Allegion representative.
- 1.4 These Terms shall take precedence over any other terms and conditions, in particular those which are referred to in any of the customer's documents.

#### 2 FORMATION OF CONTRACT

- 2.1 Unless explicitly stated otherwise, any proposal submitted by Allegion is valid for a period of 30 days from its date of issuance.
- 2.2 The contract will be formed only upon issuance of a written order acknowledgement by Allegion, or, if sooner, upon the execution of the order.

#### 3 PRICIN

- 3.1 Unless agreed otherwise, prices are quoted EXW Allegion factory (Incoterms 2000), inclusive of standard domestic packaging for truck transport and shall be exclusive of VAT or any other applicable tax or duty which the customer will pay in addition to the prices.
- 3.2 Prices are valid for shipment of products or performance of services during the on-going calendar year. Allegion may apply a price indexation mechanism for shipment or performance in subsequent years.
- 3.3 Prices are based upon the cost for labour, materials and statutory obligations ruling at the date stated on the proposal. Accordingly, Allegion may increase its prices by giving written notice to the customer prior to the delivery of products or services to reflect any increase in Allegion's cost in performing the contract due to any factor beyond reasonable Allegion's control.
- 4.1 Unless agreed otherwise, products are delivered EXW Allegion factory (Incoterms 2000) with standard domestic packaging for truck transport.
- 4.2 Delivery dates are estimates only and Allegion shall not be liable for any damages attributable to any delay or failure to deliver. In the event delivery is delayed beyond the acknowledged delivery date for any reason and at any time, Allegion shall advise the customer thereof as soon as practicable and provide a new estimated delivery date. Customer will have to notify the carrier and Allegion within 48 hours of any damage detected or detectable upon delivery.
- 4.3 If Allegion is unable to deliver the products to the customer for any reason attributable to the customer, the products will be deemed to have been delivered and Allegion may invoice and store the products until actual delivery and the customer will be liable for all related costs and expenses.

#### PAYMENT

- 5.1 Unless agreed otherwise, the price shall be paid net in GBP upon receipt of Allegion's invoice.
- 5.2 No payment shall be deemed to have been received until Allegion has received cleared funds
- 5.3 The customer shall make all payments due without any deduction whether by way of set-off. counterclaim, discount, abatement or otherwise.
- 5.4 Allegion reserves the right to suspend warranty or further deliveries of products or performance of services under any contract with the customer in the event of late or non-navment
- 5.5 Where amounts are not duly paid and without prejudice to any other right or remedy, Allegion will automatically and without any formal notification be entitled to levy interest at a rate of 1% per month. When the customer after a formal notification fails to settle the outstanding amount, Allegion will automatically be entitled, to a fixed indemnity of 10% of the price in addition to the principal amount and interests thereon.

#### **6 DEFERRAL AND CANCELLATION**

- 6.1 Except with Allegion's prior written agreement, the Customer may not defer delivery or cancel, in whole or part, any contract. Such agreement shall be subject to the customer indemnifying Allegion in full against any loss (including loss of profit), costs, charges and other expenses incurred as a result of the deferral or cancellation.
- 6.2 Allegion reserves the right to defer the execution of or cancel the contract in the event of non- or late payment.

#### 7 TRANSFER OF TITLE AND RISK

- 7.1 Risk in the products and all liability to third parties in respect thereof shall pass to the customer upon delivery in accordance with Article 4.1 or storage in accordance with Article 4.3 (if earlier).
- 7.2 Ownership of the products shall not pass to the customer until Allegion has received in full all sums due to it in respect of the products.
- 7.3 While the ownership of the products remains with Allegion, it may, subject to the customer not having fulfilled its payment obligations, take repossession of the products are consistent of the products of the product of the products of the product of the produ
- 7.4 Until ownership has passed pursuant to Article 7.2, the customer shall not, unless

otherwise agreed in writing, Transfer ownership to a third party nor charge or encumber the products in any way and maintain the products in satisfactory condition insured on Allegion's behalf for their full price.

#### 8 WARRANTY

- 8.1 Subject to the conditions set forth herein, Allegion warrants that its Products are free from defects of material and workmanship
- 8.2 The following warranty periods apply:
- a) Products: 14 (fourteen) months from the date of shipment or 12 months from date of installation/ commissioning by Allegion whichever is earlier;
- b) Repaired or replacement products (or parts): the remainder of the warranty period pursuant to Article 8.2(a)
- 8.3 If a Product does not conform to this warranty, Allegion shall at its sole option repair or replace such product (or the defective part thereof), or if the products (or defective part thereof) cannot be repaired or replaced for any reason, refund the Price of such products, provided that, if Allegion so requests, the customer returns the product to Allegion. Any product returned to Allegion which cannot be repaired will belong to Allegion. Replacement products (or parts) will be delivered EXW (Incoterms 2000). Freight and return costs of defective, repaired or replacement products (or parts) will be borne by customer. When products (or parts) are repaired on site, labour costs, as well as travel and residence expenses incurred by Allegion are borne by the customer as per Allegion's then applicable labour rates
- 8. 4 In relation to services (including but not limited to installation works), Allegion warrants that the services will be provided using reasonable skill and care for a period of 7 days from completion of such services and Allegion's obligation under this warranty is limited to correcting any improperly performed services.
- 8.5 Allegion Parts shall be warranted for 12 months from the date of shipment to be free from defects of material andworkmanship and Allegion shall, at its discretion replace or repair Parts shown to be defective provided the Parts were installed, operated and maintained in accordance with Allegion recommendations.
- 8.6 The customer will inform Allegion in writing of any defect or deficiency in the products, parts, or services within 8 calendar days of the time such defect or deficiency becomes apparent, in absence of which the customer forfeits its rights under the warranty.
- $8.7\,\mathrm{In}$  the event of a warranty claim, Allegion has the right to inspect such products, parts and services.
- 8.8 Non- Allegion products shall have such warranties as are provided to Allegion by the respective manufacturer and/or supplier. Beyond its standard product portfolio, Allegion provides no additional warranty and accepts no liability for third party products, which are integrated in Allegion products.
- 8 9 The warranty will not apply to:
- a)In the event of normal wear and tear or corrosion;
- b) products, parts and services which are not installed, stored or used correctly in accordance with Allegion's instructions or which are damaged, misused, hacked or otherwise manipulated by customer or third party in an unauthorized manner;
- c) Products, parts and services which are not maintained in accordance with Allegion's instructions;
- d)Product, parts and services which are modified without Allegion's written approval or damaged by any act beyond Allegion's control.
- 8.10 Once complied with this Article, Allegion shall have no further liability for a breach of warranty in respect of such products or services.

#### 9 PERIOD OF WORK/ SAFETY/OTHER OPERATIONS

- 9.1 The quotation for services and installation works is based upon working during normal trading hours Monday through Friday with continuity unless alternative times and periods are stated in the quotation at additional costs.
- 9.2 Customer shall provide to Allegion free and safe access to all sites and systems at all times, failure of which will entitle Allegion to suspend and/or abort any further performance until such free and safe access is restored in addition to any other rights set forth in the Terms, including but not limited to Sec. 12 hereof. Furthermore, customer shall provide at no cost light, heat, power, water and any other services necessary for Allegion's execution of the works.
- 9.3 If any repairs to finished work are necessary through damage caused by alterations by third parties, these shall be regarded as extra and charged to customer according to the work involved
- 9.4 Building operations or works by third parties is to be finished before installations of Allegion commence and such structures to which Allegion's Products are fitted shall be suitable for that purpose. Prompt receipt of, and prompt access to, Customer's equipment and all information necessary to complete the services. In no event will any delivery date be construed as falling within the meaning of "time is of the essence." Partial delivery shall be accepted by Customer and paid for at the price and on the terms stated herein. Any partial delivery shall constitute a separate sale, and payment shall be separately made when due. If any part of a delivery hereunder is not delivered by Company in accordance with Customer's purchase order, this Agreement shall not be affected thereby.

#### 10 FORCE MAJEURE

10.1 Allegion reserves the right to defer the delivery date or to cancel the contract in whole or in part, if it is prevented from or delayed in the carrying on of its business due to circumstances beyond its reasonable control, including (without limitation) acts of God, accidents, compliance with any law, regulation or other government order (whether or not valid), war or national emergency, riots, fire, industrial action, shortages of labour, restraints or delays affecting carriers or inability or delay in obtaining supplies of adequate or suitable materials. If the force majeure event continues for a continuous period in excess of 6 months, either party shall be entitled to terminate the contract.

#### 11 LIMITATION OF LIABILITY

- 11.1 Unless otherwise provided for by mandatory provision of applicable law, Allegion's total liability for direct damages, if and when established, shall be limited to the price of such products and/or services. Allegion shall not in any case be liable to the customer for any consequential damage or indirect damage whatsoever, including but not limited to loss of profit, special, punitive or exemplary damages.
- 11.2 Catalogs, price lists, illustrations, drawings and any other sales literature are issued by Allegion for information purposes only and can be updated or amended from time to time. Any typographical, clerical or other error, mistake or omission in these documents or in offers, order acknowledgements, drawings, specifications, invoices or other documents shall be subject to correction without any liability on the part of Allegion.
- 11.3 Allegion shall not be responsible for any consequence arising of or resulting from the use of incomplete or incorrect information communicated by the customer to Allegion and costs incurred by Allegion as a result of such inaccuracy and/or incompleteness of information will be charged to the customer.
- 11.4 Customer retains responsibility for the security system design, its drawings and in particular the verification of the accuracy and suitability of the products and services within customer's system, unless Allegion has expressly accepted to render such design activities for the Customer and to assume such liabilities thereto.

#### 12 INTELLECTUAL AND INDUSTRIAL PROPERTY RIGHTS

- 12.1 The customer acknowledges that it will acquire no intellectual or industrial property rights in any patent, trademark, trade name, drawings or any other related right owned, used or developed by Allegion prior to or during the execution of the contract.
- 12.2 The customer agrees not to do or permit to be done anything which might in any way adversely affect the validity or value of Allegion's intellectual or industrial property rights or the goodwill therein.
- 12.3 Notwithstanding the foregoing, when Allegion develops specific software or source code for a customer, this customer is, conditional upon payment of the agreed royalties, granted a non-transferable, non-exclusive right of usage for the lifetime of the concerned Allegion security system on the agreed project site.

#### 13 ADDITIONAL TRAVELLING

13.1 If fares and travelling beyond the amount of Allegion's normal allowances are incurred owing to an additional visit or visits being rendered necessary from lost journeys or non-continuity through no fault of Allegion, the excess amount shall be charged to the customer.

#### **14 MISCELLANEOUS**

- 14.1 The customer shall not be entitled to assign the contract or any part of it without the prior written consent of Allegion. Allegion may assign the contract or any part of it to any person, firm or company.
- 14.2 If any provision of these Terms is or shall become wholly or partly void, it shall to the extent of such voidness be deemed severable and the remaining provisions of these Terms and the remainder of such provision shall continue in full force and effect. To the void provision shall be substituted a valid provision which comes as close as possible to the economic purpose of the void provision.

#### 15 LAW AND JURISDICTION

- 15.1 All Contracts are governed by English law. The United Nations Convention on Contracts for the International Sale of Goods (CISG) does not apply.
- 15.2 Parties will refer any dispute to the exclusive jurisdiction of the Courts of Birmingham, England.



## **How to Order:**

Follow the steps below to build the full part number for the reader you wish to order. Use the sample below to determine how to write your part number on your PO.



#### 1. Choose Your Reader Model

#### 2. RS-485 Capability

aptiQ readers (multi-technology only) have been designed with an option to interface directly with controllers that utilize RS-485 protocol. RS-485 is a communication protocol that allows a two way communication between the reader and the panel, for example OSDP protocol.

To order readers with RS-485 capability, add **"-485"** after the reader model number. If you are using the standard Wiegand protocol, do not add a suffix (leave blank).

#### 3. Reader Color Options

aptiQ and XceedID Readers are available in four color options. Add the appropriate suffix after the reader model number and RS-485 option (if applicable).

Black (standard) – do not add a color suffix, **leave blank** 

Cream - add "C"

Warm Tone Brown - add "BN"




